Many people give regularly of their time and material goods to support the Priestly Fraternity of St Peter (FSSP) and our mission. Without their generosity our work would not be possible.

Some people also wish to remember us in their Will.

This brochure contains important information on how you can leave a lasting legacy to future generations of Catholics. We encourage you to read it carefully and prayerfully.

What is a bequest?

A bequest is a gift dedicated in your Will. It can be as little or as large as you wish and not necessarily monetary.



Why give a bequest to the Fraternity of St Peter?

Your gift will help us continue our mission of celebrating the Sacraments in their traditional forms, catechizing children and adults, providing pastoral and sacramental care to the sick and the dying, and training seminarians.

The FSSP exists to meet the liturgical and pastoral needs of those faithful attached to the Roman liturgy as it was celebrated prior to the Second Vatican Council (The Traditional Latin or *Tridentine Mass*). Our charism, originally approved by Pope St John Paul II in 1988, was confirmed by Pope Francis in February 2022.

Since our arrival in Oceania in 2000, we have seen sustained and vigorous growth and we now work in the Archdioceses of

Adelaide, Canberra & Goulburn, and Sydney, and in the Dioceses of Auckland, Broken Bay and Parramatta.

If you wish to be part of our mission of handing on the treasure of the Latin Mass to future generations, a bequest is one of the most effective ways to do this. By giving us a bequest, you will be ensuring that your legacy continues to benefit others. You will be contributing to the ongoing sanctification of both the priests and people who worship using this priceless gift – a gift meant to be shared – *The Traditional Latin Mass*.

Mass is offered monthly for all benefactors of the FSSP in the District of Oceania. Your generosity will not be forgotten.



A bequest may take several forms:

A monetary amount – you specify an amount of money to be given from your estate;

A percentage of your estate – you nominate a percentage of your estate, rather than a specific amount;

The residue of your estate – you give what remains of your estate after any other specific considerations, e.g. for your family, friends or other charities;

Other bequest options – gifting specific assets, such as property, shares, superannuation or other disposable valuables.

How do you leave a bequest?

We recommend you seek advice from your solicitor on the most appropriate wording for leaving a bequest when making or updating your Will. In this way you can be assured that your wishes will be fulfilled.

It is generally preferred that bequests be given for use at the discretion of the Fraternity, but, should you have a specific purpose in mind for your bequest, please contact the District Superior or Bursar prior to writing your Will.

The following is an example of possible wording you could use:
